- (1) The redeemable benefit can only be used for the below options and only ONE option can be exercised upon occurrence of any of life celebration events.
  - (a) Option 1: To pay the **FIRST** premium of a new investment-linked insurance policy with the Company up to RM 1,500 or annual premium of the new policy, whichever is lower.
  - (b) Option 2: To credit RM500 cashback to policy owner's bank account for Life Assured with entry age 25 and below.

<b>Buying a New Electric Car</b>	The Life Assured buying a new car which can be powered by an electric motor that draws electricity from a battery and capable of being charged from external sources.	A copy of vehicle registration certificate.
<b>Conceiving a child</b>	The Life Assured's or the Life Assured's legal spouse's conception of a child that is at least 18 weeks into the gestation period, substantiated by a report from attending Obstetrician and Gynecologist (O&G) confirming such conception.	A copy of Latest Obstetrician and Gynae Report
<b>Graduation</b>	A Life Assured's completion of tertiary education in higher education providers in or outside Malaysia, for Bachelor's degree or postgraduate's qualification (including Postgraduate Certificate, Postgraduate Advanced Diploma, Master's degree or Doctoral degree).	A copy of certificate of graduation.
<b>Marriage</b>	A registered marriage that is legally recognised under the laws of Malaysia.	A copy of certificate of marriage.
<b>Owning a New House</b>	The Life Assured owning a new house including but not limited to terrace, apartment or condominium.	A copy of stamped sales & purchase agreement (or its equivalent for a foreign property purchase).

- (2) The benefit could only be redeemed within six (6) months upon occurrence of any of the life celebration events.
- (3) The redemption is ONLY claimable once per lifetime.
- (4) This option can be exercised at any time before the policy anniversary where the Life Assured attains the age of ninety-nine (99) years old.
- (5) The premium payable for the policy must all be paid up to date for at least two (2) years after the Issue Date or Reinstatement Date of the policy whichever is later.
- (6) The policy must be in force for two (2) years after the Issue Date or Reinstatement Date of the policy whichever is later.
- (7) A certified true copy of required certificates or documents as proof of the applicable life celebration events is required to be submitted upon redemption.
- (8) For the new policy purchase:
  - (a) Upon redemption, the RM1,500 may be utilised for the purchase of a new policy by Policy Owner or Policy Owner's immediate family members (i.e. spouse, child, or parents).
  - (b) The new policy must be in annual mode with minimum annual premium of RM1,800.
  - (c) This option is not allowed to use together with similar rewards as may be determined by company under any other polices (i.e. New Born Reward and /or Welcome Gift).
  - (d) If the new policy is cancelled during the cooling-off period of fifteen (15) days, company shall deduct RM1,500 from the amount to be refunded.
